



BACKGROUND:

The Coachella Valley Housing Coalition sponsors the JFM College Scholarship Fund Program that serves more than 100 low income students annually that live in the communities of Blythe, Mecca, Thermal, Coachella, Indio, La Quinta, Cathedral City, Desert Hot Springs, and Palm Springs.

The Indio Rotary started the Math Field in 1995. This event encourages student to study and enjoy math and motivates them to develop and apply their math skills and to demonstrate their knowledge of mathematics. It is a community event that includes all three local school districts in the Coachella Valley.

The Palm Desert Rotary Club Foundations raises funds for scholarship for students attending Palm Desert High School and College of the Desert.
