### **Summary**

Riverside County Information Technology (RCIT) has a total of thirteen (13) critical communication sites powered by diesel generators. The sites are integral parts of communication for the Public Safety Enterprise Communication (PSEC) and are in remote locations where fuel delivery is difficult.

### **BACKGROUND:**

Summary (continued)

Interruption of fuel services to the below communication sites will cause service outages to the PSEC system, radio transmitters for Riverside County Fire, and much of the County's CORNET and telephone networks. The approval of the amendment before the Board today will provide diesel fuel through February. Purchasing is in the process of releasing a Request for Quote ITARC-222 for fuel delivery to the mountain top sites.

In 2012 quotes were obtained from two (2) vendors to provide diesel fuel to the mountain top sites and a purchase order was issued to the lowest responsive, responsible vendor. Subsequently a contract was issued for one (1) year. The contract expired on June 30, 2013; fuel delivery has continued to the sites without having

Fueling the sites keeps the public safety communications sites functioning to assist in public safety.

## **Contract History and Price Reasonableness**

Teagarden currently holds a contract approved by the Board of Supervisors to fuel the Santa Rosa Peak location and held the expired contract to deliver to the other mountain top sites. Teagarden charges OPIS price per gallon with a flat fee for delivering fuel to these remote locations not to exceed a maximum reimbursable amount of \$225,000.00 for all sites.
