Administrative Services

We propose the monthly Administrative Services rate for fiscal year 2015 remain unchanged at \$25.20.

In fiscal year 2015, Fleet Services will waive 75% of Administrative Service Charges projected at \$908,334. Attachment B provides an illustration of how much departments may save based on a percentage of fiscal year 2013 actual charges. In fiscal years 2013 and 2014, 100% of administrative charges were waived. Fleet Services is no longer in a financial position to waive 100% of this charge.

Fixed Monthly Maintenance Charge

We propose the fixed monthly maintenance rate for fiscal year 2015 remain unchanged at \$30.60 per vehicle.

In fiscal year 2014, 33.7 percent of this charge was waived. In fiscal year 2015, vehicle maintenance cost and other costs will escalate sharply. Fleet Services proposes to decrease its net assets by \$690,415 to absorb these costs rather than pass them to other County departments. Therefore, there will be no change in fixed maintenance rates over fiscal year 2014 rates but no portion of this charge will be waived.

Automated Car Wash

We propose the automated car wash rate for fiscal year 2015 remain unchanged at \$3 per wash.

Impact on Residents and Businesses

Fleet Services provides County Departments and Agencies vehicles acquisition and lease services, maintains a central car pool, as well as maintenance, fuel, and other related vehicle services to provide safe and cost effective vehicle operations for County functions. There is no direct impact on residents and businesses.
