After hiring her as a waitress and a baker for the cafe, Jack fell in love with her and put his life on the line when he rescued her from certain death at the hands of the Nazis.

When the war ended, Jack and Roza immigrated to the United States where he worked long hours in the restaurant and catering industry to provide for his family. He believed in the American dream, invested wisely, and ultimately amassed a substantial real estate portfolio.

For Jack's heroism, Yad Vashem, the Holocaust authority, awarded him in 2003 with Israel's highest honor, the Righteous Among the Nations Medal. This prestigious event was held at the Simon Wiesenthal Center in Los Angeles with 500 people in attendance.

An instrumental force in the community, Frank helped to develop and grow the Palm Desert area of the Coachella Valley. His family moved to the Valley in 1964 when Frank and his partners bought and revitalized the Palm Desert Country Club Golf Tournament which ran from 1965 to 1975 in conjunction with the Bob Hope Desert Classic to showcase future stars of professional golf. In 1981, the partners completed the development of Palm Desert Resort Country Club, the Country's largest condo-hotel project at the time. In 1986, he retired as a fulltime real estate developer and then cofounded Desert Arbitration and Mediation.

Frank was a generous supporter of both formal charities and small start-up operations and individuals in need. He has also been an active member of many organizations including the Palm Desert Rotary, the Indio Lions Club, the Boys and Girls Club, President of the Palm Desert Association of Realtors, Chairman of the Bermuda Dunes Community Council, a Director of the California Association of Realtors, and a founding member of the Brainstormers.
