BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Community Connect - \$2,000** funding will be used to support the 211 program which offers over 3000 resources to assist residents in finding help for critical human and health services. Some of these services include: battered women's shelters, youth programs, child protective services, disabled transportation, child care, adult protective services, counseling, adult day care and foster care. Last year, 211 received 12,970 calls from District 1 residents.
2. **Janet Goeske Foundation -\$2,000** funding will be used to help support the many programs and services at the Janet Goeske Center including 150 regular weekly activities, special events and educational seminars.
3. **Friends of the Woodcrest Library -\$2,000** funds will be used to support the Library Summer Reading Program "*Paws to Read*" which will benefit 800 children, adults and teens. This program will run from June 16, 2014 to August 9, 2014.
4. **Friends of the Woodcrest Library-\$1,500** funds will be used to bring back the M.A.R.S (Mobile Activities Recreation Services) Summer Program to the library. M.A.R.S will promote creativity, team building, physical fitness and environmental awareness every Friday from June 20, 2014 to August 15, 2014 from 9AM-12PM. Kids ages 6-13 are welcome to attend.
