

On motion of Supervisor Benoit, seconded by Supervisor Stone, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, February 11, 2014, be adjourned in memory of Don Reuben, an 85-year-old "nationally known lawyer" who was generous with his time and resources for charitable endeavors.

During a legal career of 65 years, Don was counsel to the Chicago Tribune and its newspaper and broadcast subsidiaries for more than 40 years. He began to practice law in Chicago in 1952 and tried many criminal and civil cases. He became the Midwest's most prominent media and First Amendment Lawyer, litigating or counseling in over 700 libel and First Amendment cases. In 1996, at age 68, Reuben sat and passed the California Bar and then began practicing both in California and in Illinois. In his later years, he served as a professional arbitrator and as a California Superior Court trial judge pro tem. He wrote legal articles and often lectured on the law.

A true humanitarian, Don served as Director, Officer, and General Counsel of the WWII Palm Springs Air Museum for many years. He was also a member of the College of the Desert Foundation, the Coachella Valley Community Blood Bank, The Weil Institute of Critical Care Medicine, Friends of the Coachella Valley Animal Campus, and the Chicago Lincoln Park Zoo.

Don was a devoted family man and a "great lover of dogs." His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.

On motion of Supervisor Benoit, seconded by Supervisor Stone, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, February 11, 2014, be adjourned in memory of Ralph McPherran Kiner, a 91-year-old resident of Rancho Mirage and "Hall of Famer" whose "youthful ambition and fierce work ethic led him to the major leagues, where he became the premier power hitter of his generation and eventually an iconic voice for legions of New York baseball fans."

Not long after Ralph was signed to the Pittsburgh Pirates organization in 1940, World War II broke out and he put his baseball career on hold. Volunteering to join the Navy, he was trained as a pilot and flew antisubmarine missions in the Pacific. Ralph returned from the war in 1945 and made his major league debut on April 12, 1946. He played for 10 seasons from 1946 to 1955 and is still widely remembered for his consistent dominance during his playing career.

In 1955, Ralph was offered the job of general manager of the San Diego Padres. While game day radio broadcasts were still in their infancy, he provided a "one-man" analysis of each game in addition to his daily duties of running the club. In 1962, he accepted a job as a member of the original broadcast team for the New York Mets Expansion Club. A postgame show titled "Kiner's Corner" became a huge hit among fans and was instrumental in changing the way broadcasters interacted with players off the field. Still an active broadcaster at 90, Ralph has outlasted most of his peers through the decades.
