Summary

The jurisdiction will reimburse the department based on the associated direct election costs.

RESOLUTION NO. 2013-65

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RANCHO MIRAGE, CALIFORNIA, REQUESTING THE RIVERSIDE COUNTY BOARD OF SUPERVISORS TO RENDER SPECIFIED SERVICES TO THE CITY OF RANCHO MIRAGE FOR THE CITY'S GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, APRIL 8, 2014

WHEREAS, a General Municipal Election is to be held in the City of Rancho Mirage, California, on April 8, 2014; and

WHEREAS, in the course of conducting the election it is necessary for the City to request certain election services of the County; and

WHEREAS, the City of Rancho Mirage will reimburse the County for all election services rendered for the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RANCHO MIRAGE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. Request for Election Services.

That pursuant to the provisions of Section 10002 of the California Elections Code, the City Council requests that the Riverside County Board of Supervisors permit the County Election Department to render election services to the City of Rancho Mirage as may be requested by the City.

Section 2. Reimbursement.

That the City shall reimburse the County for election services rendered upon presentation to the City of an appropriate invoice.

Section 3. Certified Copies of Resolution.

That the City Clerk is directed to forward without delay to the Board of Supervisors and to the County Election Department certified copies of this Resolution.

Section 4. Certification.

That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of

original resolutions.




