**BACKGROUND:**  
**Summary**

On June 19, 2012, the Board of Supervisors approved the construction agreement between the County of Riverside and Dalke and Sons Construction, Inc. of Riverside, California in the amount of \$196,480 to convert an existing holding cell into two safety cells for the Smith Correctional Facility Safety Cells project. During construction, one change order was approved in the amount of \$5,528, increasing the total contract value to \$202,008. The approved change order amounts to 2.8% of the original contract.

The project has been inspected and found to comply with all contract requirements. This Board action will release the contract retention funds of \$10,100 to Dalke and Sons Construction Company, Inc. The contract retention funds are within the overall project budget and no budget adjustment is required.

**Impact on Residents and Businesses**

Minor impacts due to the temporary closure of holding cells caused some inmates to be relocated to other holding cells within the facility. No businesses were impacted as a result of the project. Recording the Notice of Completion for Dalke and Sons Construction, Inc. will have no impact on residents and businesses.

**Contract History and Price Reasonableness**

On April 18, 2012, four contractors attended a mandatory job walk for the project. On May 2, 2012, the bids were opened and Dalke and Sons Construction, Inc. was determined to be the lowest responsive and responsible bidder.

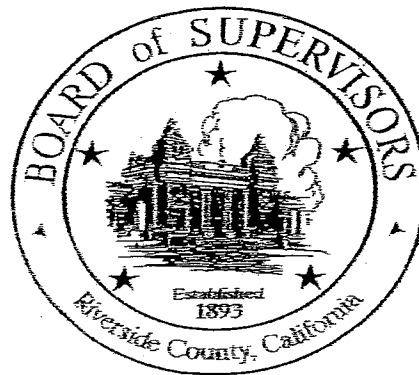

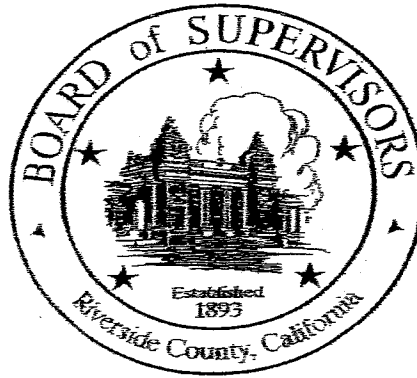
