RECOMMENDED MOTION: That the Board of Supervisors:

BACKGROUND:

Summary

The County received approval to begin enrollment in the Low Income Health Program (LIHP) beginning in January 2012. Effective July 1, 2012 a fund was established to track LIHP revenue and expenditures associated with payments to out-of-network service providers. Although the program ended December 31, 2013, additional revenue is anticipated and providers are allowed to submit invoices through December 31, 2014 for payment. A budget adjustment is requested to reflect the revenue and expenses anticipated for the remainder of the fiscal year.
