
1. Approve and Authorize the Chairman of the Board to sign the amendments for the indigent defense contracts with adjustments of rates effective March 1, 2014 for Barbara Brand and March 24, 2014 for JDP and with five (5) one year extensions in the following annual amounts:
Law Offices of Barbara M. Brand - \$1,853,496 and JDP - \$538,425.

BACKGROUND:

Summary

On February 25, 2014 a formal request was made to accept an offer of a 7-1/2% reduction in attorney fees for the contract with Virginia Blumenthal and Criminal Defense Lawyers for a five (5) year extension. In addition, a request was made to accept an offer for a 5% reduction in attorney fees with no change to the trust fund in exchange for a three (3) year extension for the Law Offices of Barbara M. Brand.



BACKGROUND:

Summary (continued)

The Board accepted the offer from Virginia Blumenthal and Criminal Defense Lawyers. However, they entertained a request for a two week continuance for the offer from Barbara M. Brand.

Barbara M. Brand has accepted the 7-1/2% attorney fee reduction and the signed contract amendment is attached. During the public process that was taking place, JDP, who has a separate contract for Juvenile Indigent Defense, voluntarily offered to match the reductions being offered by Virginia Blumenthal and Criminal Defense Lawyers. The contract amendment is attached for their attorney fee reduction and a five (5) year extension. The effective date for the JDP agreement is modified to March 24, 2014 to accommodate full months since their anniversary date is currently November 23, 2014. Thereby, we can make all of the Indigent Defense contracts co-terminace.

Both vendors have agreed to make the rate reductions this month as indicated so the County can benefit from their offer of reduced rates. Attachment A is a table showing the contract changes.

Point of Clarification

Virginia Blumenthal and CDL – Cover all western Riverside County Adult Indigent Defense.

JDP – Covers all western Riverside County for Juvenile Indigent Defense.

Barbara Brand – Covers the Desert and Blythe for Adult and Juvenile Indigent Defense.

The action taken on February 25, 2014 approved the rate change and a five (5) year extension for Virginia Blumenthal and CDL resulting in a \$4,413,334 savings to the county over the five (5) years extension and early rate reduction.

Today's agenda item is requesting similar approval for Barbara M. Brand and JDP with the same reduction of attorney rate of 7.5% resulting in a \$967,484 savings to the county over the five (5) years and early rate reduction.

If these two contract extensions are approved, the total aggregate savings for all four (4) contracts for the entire term will be \$5,380,818.

The Agreement between Riverside County, herein referred to as COUNTY and Juvenile Defense Panel, herein referred to as ATTORNEYS, is amended as follows:

1. On page 2 of the Agreement, amend Section 2 the "Term of Performance":
To amend all reference to the Term of Performance from expiration of November 23, 2014 to a Term of Performance of Board Approval through June 30, 2019, renewed in one-year increments, unless terminated as specified in Section 9 TERMINATION. All other terms of the Term of Performance in the Agreement shall apply.
2. On page 5 of the Agreement, amend Section 6 the "COMPENSATION";
To amend reference to the maximum annual contract cost to \$485,625 (four hundred eighty five thousand six hundred twenty five dollars) at a monthly rate of \$40,468.00 (forty thousand four hundred sixty eight dollars).
3. On page 6 of the Agreement, Section 8 the "EXPENSES";
The maximum annual payment for expenses is fifty two thousand eight hundred dollars (\$52,800). The monthly rate is four thousand four hundred dollars (\$4,400).
4. On page 5 of the Agreement, amend Section 7.1 the "NEW FILINGS";
Case range shall be unlimited for the Agreement. No minimum or maximum to benchmarks.
5. On page 14 of the Agreement, amend Section 23 the "PERIODIC REVIEW";
Section 23 will be removed from the Agreement and Section 24 "NOTICES" will become Section 23. Case range shall be unlimited for the Agreement.
6. All other terms and conditions of the Agreement are to remain unchanged.

The Agreement between Riverside County, herein referred to as COUNTY and Law Office of Barbara M. Brand, herein referred to as ATTORNEYS, is amended as follows:

1. On page 3 of the Agreement, amend Section 2 the "Term of Performance":
To amend all reference to the Term of Performance from expiration of June 30, 2014 to a Term of Performance of Board Approval through June 30, 2019, renewed in one-year increments, unless terminated as specified in Section 9 TERMINATION. All other terms of the Term of Performance in the Agreement shall apply.
2. On page 9 of the Agreement, amend Section 7 the "COMPENSATION";
Monthly rate shall be \$146,458 (one hundred forty six thousand four hundred fifty eight dollars). Annual amount shall be \$1,757,496 (one million seven hundred fifty seven thousand four hundred ninety six dollars dollars)

Monthly rate shall be eight thousand dollars (\$8,000). Annual amount shall be ninety six thousand dollars (\$96,000).

2. Authorize the Purchasing Agent, in accordance with Ordinance 459.4, to exercise the renewal Options for a maximum of five years in one-year increments to June 30, 2019, based on the availability of fiscal year funding and the performance of the contractors as determined by the County, and;
3. Authorize the Purchasing Agent to also sign amendments that do not change the substantive terms of the agreement and that do not increase the compensation initially approved for each vendor.

BACKGROUND:

In September 2010, County Purchasing issued a formal RFP #EOARC-019 to obtain indigent defense legal services. Three proposals were received and after several months of negotiations, the County entered into five year contracts with these three firms. These agreements are set to expire on June 30, 2014. Because these contracts have run extremely well and there are no other additional known firms to take on these services, the County has negotiated a reduction in the fixed monthly fee with each firm along with a significant reduction on the cap for pass through expenses for outside services in exchange for extending the contract for up to five additional one-year periods. If approved, the new rates will go into effect March 1, 2014 and provide additional savings in the current fiscal year. Approval of these contract amendment will provide the County \$2,730,000 in direct savings for the fixed monthly fees, as well as a \$2,000,000 reduction in pass through trust fund costs over the term of these amendments.

Impact on Citizens and Businesses

Riverside County is required to retain legal services to represent indigent defendants for whom the Riverside County Public Defender's Office (PD) declares a conflict of interest, including misdemeanors, felonies, and the Welfare.

The area serviced under this current agreement is defined as all branches of the Riverside Superior Court across three distinct regions: Western Riverside, which includes Riverside, Corona, Banning, and Moreno Valley courts; Mid-County, which includes Hemet, Temecula, the Southwest Justice Center, and East County, which includes Indio and Blythe. Matters to be handled include violation of probation hearings, misdemeanors, and felonies (including non-death penalty capital cases when the Public Defender and Capital Public Defender Offices declare a conflict), as well as other miscellaneous appointments by the court, wherein the Public Defender has declared a conflict and the defendant/party meets the Public Defender indigence standard, which is consistent with 45 Code of Federal Regulations 1611 et seq.

Contract History and Price Reasonableness

The County entered into negotiations with the Law Offices of Barbara M. Brand, Virginia M. Blumenthal, a Professional Law Corp., and Criminal Defense Lawyers to review attorney's fees on the current agreements. Because the vendors are exercising excellent management controls for their outside contract efforts, we have been able to reduce the potential expenditures through the trust funds by \$2,000,000 over the life of these extensions. The County successfully negotiated new proposed fees that would become effective on March 1, 2014 and remain fixed for three (3) years for Barbara Brand and for five (5) years for Virginia Blumenthal and CDL.
