RECOMMENDED MOTION (continued):

3. If the owners or whoever has possession or control of the real property do not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the accumulation of rubbish by removing and disposing of the same from the real property.

4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.

5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance No. 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

1. An initial inspection was made on the subject property by Code Enforcement Officer Matt Jones on March 8, 2013. The Inspection revealed the accumulation of rubbish on the subject property in violation of Riverside County Ordinance 541. The rubbish consisted of, but was not limited to: household trash, plastic, metal and wood.

2. Follow up inspections of the above-described real property on March 26, 2013, April 11, 2013, June 6, 2013 and October 8, 2013, revealed the property continues to be in violation of Riverside County Ordinance No. 541.

3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of accumulated rubbish.

Impact on Citizens and Businesses

Failure to abate will have a negative impact on citizens or business due to health and safety hazards, nuisance, and potential impact on real estate values.

9 I, Samantha Phillips, declare that the facts set forth below are personally known to me except to
10 the extent that certain information is based on information and belief which I believe to be true, and if
11 called as a witness, I could and would competently testify thereof under oath:

12 1. I am currently employed by the Riverside County Code Enforcement Department as a
13 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting
14 properties for violations and enforcement of the provisions of Riverside County Ordinances.

15 2. I am informed and believe and based thereon allege that on March 8, 2013, Officer Jones
16 conducted an initial inspection of the real property described as 33099 Old Highway 74, Hemet,
17 Riverside County, California and further described as Assessor's Parcel Number 458-120-054
18 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page
19 indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as
20 Exhibit "A."

21 3. A review of County records and documents disclosed that THE PROPERTY is owned by
22 Doris F. Bond and The Estate of Donna Ann Colclasure (hereinafter referred to as "OWNERS"). A
23 certified copy of the County Equalized Assessment Roll for 2013-2014 tax year and a copy of the report
24 generated from the County Geographic Information System ("GIS") is attached hereto and incorporated
25 herein by reference as Exhibit "B."

26 4. Based on the Lot Book Report from RZ Title Service dated April 9, 2013 and updated on
27 October 1, 2013, it is determined that other parties may potentially hold a legal interest in THE
28 PROPERTY, to wit: State of California Franchise Tax Board, (hereinafter referred to as "INTERESTED

1 PARTY"). True and correct copies of the Lot Book Reports are attached hereto and incorporated
2 herein by reference as Exhibit "C."

3 5. I am informed and believe and thereon allege that on March 8, 2013, Officer Jones drove
4 to THE PROPERTY to conduct an initial inspection. Officer Jones observed accumulated rubbish, which
5 consisted of, but was not limited to the following materials: household trash, plastic, metal and wood.

6 6. As a result of the accumulated rubbish, THE PROPERTY constituted a public nuisance in
7 violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 541.

8 7. On March 8, 2013, a Notice of Violation for accumulated rubbish was posted on THE
9 PROPERTY.

10 8. On March 15, 2013 and November 5, 2013, a Notice of Violation was mailed to OWNERS
11 by first class mail. On May 8, 2013, a Notice of Violation was mailed to INTERESTED PARTY with return
12 receipt requested.

13 9. A true and correct copy of each Notice issued in this matter and other supporting
14 documentation are attached hereto and incorporated herein by reference as Exhibit "D."

15 10. A site plan and photographs depicting the conditions of THE PROPERTY are attached
16 hereto and incorporated herein by reference as Exhibit "E."

17 11. Follow up inspections were conducted on March 26, 2013, April 11, 2013 and June 20,
18 2013. During each inspection, THE PROPERTY remained unchanged and in violation of RCO No. 541.

19 12. On October 8, 2013, I conducted a follow up inspection of THE PROPERTY which
20 revealed the accumulated rubbish remained on THE PROPERTY and in violation of RCO No. 541. I
21 measured the areas and determined the accumulated rubbish to be approximately 8,000 square feet.

22 13. Based upon my experience, knowledge and visual observations, it is my determination
23 that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the
24 general public.

25 14. I am informed and believe and based upon said information and beliefs allege that the
26 OWNERS do not have legal authority or permission to store or accumulate the above described
27 materials on THE PROPERTY.

28 15. A Notice of Pendency of Administrative Proceedings regarding the accumulated rubbish

1 was recorded in the Office of the County Recorder, County of Riverside, State of California, on
2 June 3, 2013, as Instrument Number 2013-0262705. A true and correct copy is attached hereto and
3 incorporated herein by reference as Exhibit "F."

4 16. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing
5 notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNERS
6 and INTERERSTED PARTY by first class mail and was posted on THE PROPERTY. True and correct
7 copies of the Notices, together with the Proofs of Service, and the Affidavit of Posting of notices are
8 attached hereto and incorporated herein by reference as Exhibit "G."

9 17. Removal of all accumulated rubbish on THE PROPERTY is required to bring THE
10 PROPERTY into compliance with RCO No. 541, and the Health and Safety Code. Under RCO No. 541,
11 no amount of rubbish is allowed to accumulate on THE PROPERTY.

12 18. Accordingly, the following findings and conclusions are recommended:

13 (a) the accumulation of rubbish on THE PROPERTY be deemed and declared a
14 public nuisance;

15 (b) the OWNERS or whoever has possession or control of THE PROPERTY, be
16 required to remove all accumulated rubbish within ninety (90) days of the date of the posting and mailing
17 of the Board's Order to Abate Nuisance, in accordance with all Riverside County Ordinances, including
18 but not limited to the provision of RCO No. 541;

19 (c) in the event the rubbish is not removed and disposed of according to the above
20 referenced ninety (90) day time period in strict accordance with all Riverside County Ordinances,
21 including but not limited to RCO No. 541, the rubbish may be abated and disposed of by representatives
22 of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon
23 receipt of an owner's consent or a Court Order when necessary under applicable law.

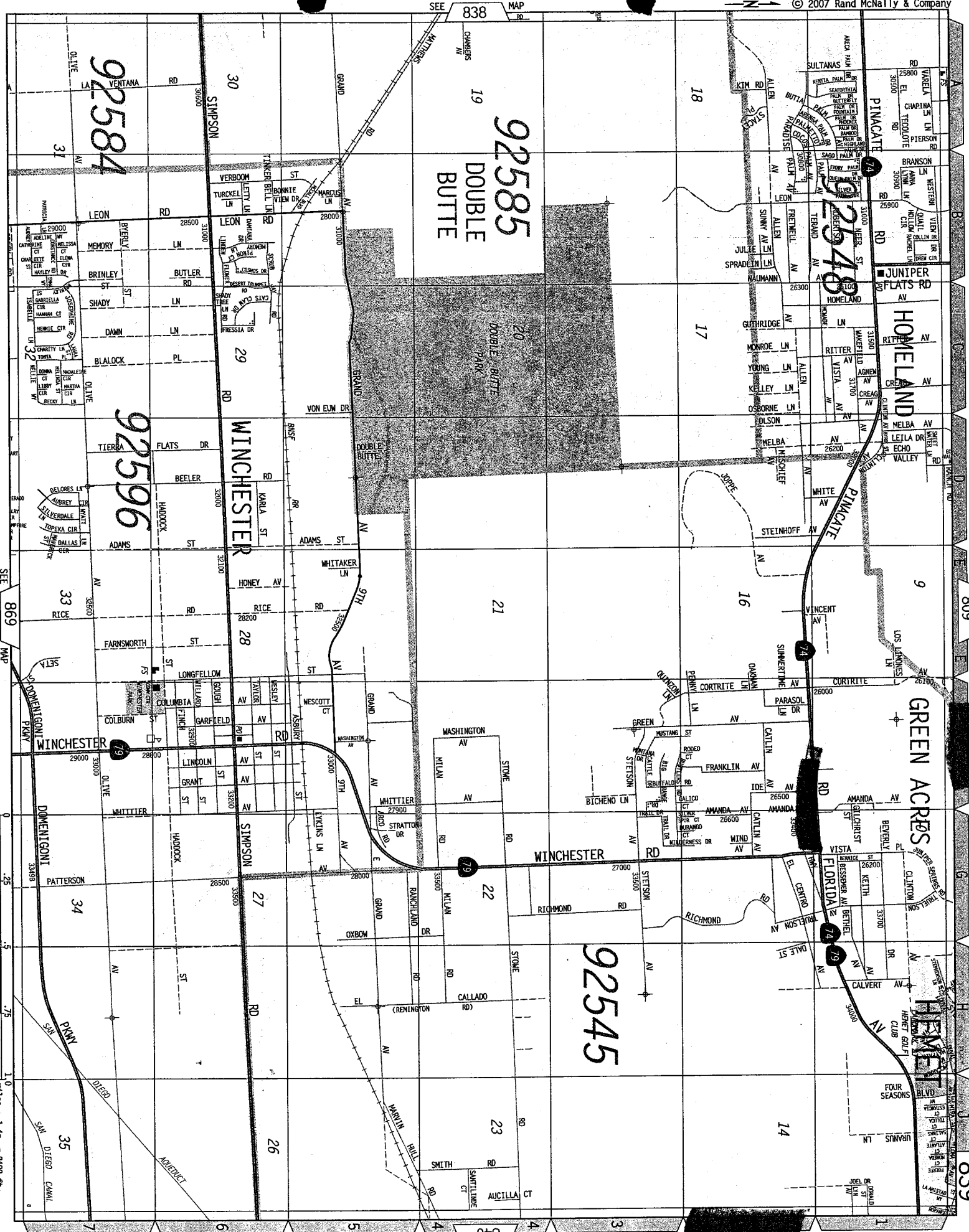

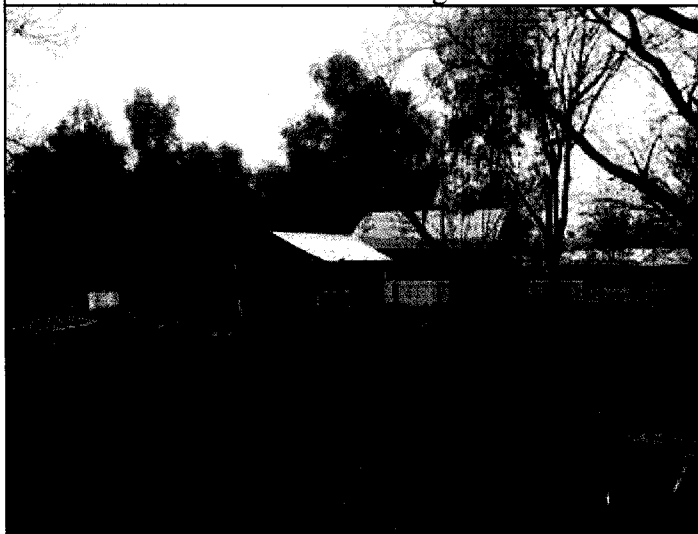
