BACKGROUND:

Summary

The Riverside Off-Highway Vehicle Enforcement Program (R.O.V.E.), is the Sheriff's innovative and effective program that has put Deputies on all-terrain vehicles (ATVs) to enforce laws concerning illegal off-highway driving, dumping, driving under the influence and environmental destruction.

The current application will begin Phase X of the Sheriff's county-wide effort with a proposed start date of September 2014. The application requests \$157,585 to support Deputy Sheriff overtime for continued and expanded patrols in problematic areas.

The grant application requires a 25% match of the total project cost of \$210,113 in the amount of \$52,528. The Department proposes contributing an in-kind match of Special Enforcement Bureau salaries. All local match contributions will come from the Department's status quo budget. Any grant awarded will be submitted to the Board of Supervisors for review and approval.

During the development of this phase of the county-wide project, the Sheriff requested public comment via a posting on the Department's web site.

Impact on Citizens and Businesses

The grant funds 75% of total project cost. The grant project focus of the Off-Highway Vehicle Enforcement Program is to enforce laws concerning illegal off-highway driving, dumping, driving under the influence and environmental destruction.


8 WHEREAS, The people of the State of California have enacted the Off-Highway

11 Facilities Operation and Maintenance Projects, Law Enforcement Projects OHV Safety and/or
12 Education Program Projects, Planning Projects, Restoration Projects, and Trail Maintenance
13 Projects for off-highway vehicle recreation; and

14 WHEREAS, the Off-Highway Motor Vehicle Recreation Division with the California
15 Department of Parks and Recreation has been delegated the responsibility to administer the
16 program; and

17 WHEREAS, procedures established by the California Department of Parks and
18 Recreation require the Applicant's Governing Body to certify by resolution the approval of the
19 Application to apply for Off-Highway Motor Vehicle Grant funds; and

20 WHEREAS, this Project appears on, or is in conformance with this jurisdiction's adopted
21 general or master plan and is compatible with the land use plans of those jurisdictions
22 immediately surrounding the Project;



13 event that it accepts the award; and
- 14 6. Certifies that the public and adjacent property owners have been notified of this Project (as
15 applicable); and
- 16 7. Appoints the Sheriff, Undersheriff, Assistant Sheriff or Chief Deputy Sheriff as agent to
17 conduct all negotiations, execute and submit all documents including, but not limited to
18 applications, award agreements, amendments not increasing the award by more than 20%
19 and that do not materially change the scope of the grant project, and payment requests
20 which may be necessary for completion of the Project.
