BACKGROUND:

Summary

The people of the State of California have enacted Senate Bill 1330 (Lockyer, Statutes of 1997 Chapter 2.5), which authorizes the California Department of Resources Recycling and Recovery (CalRecycle) to award Farm and Ranch Solid Waste Cleanup and Abatement Grants to eligible applicants to pay for the costs of cleanup, abatement, or other remedial action related to the disposal of illegal solid waste on farm or ranch property.

BACKGROUND:

Summary (continued)

No matching funds are required for this reimbursement grant. Applications for this grant are site specific and can be submitted four times a year. Grants are limited to \$50,000 per cleanup or abatement project, with a limit of \$200,000 per fiscal year. Utilization of this grant will allow the Code Enforcement Department to abate solid waste on properties where recovery of abatement costs may not be practical due to high cost or other factors. This grant should allow the Code Enforcement Department to conduct more solid waste abatements annually with the limited resources available.

Upon approval of the grant application, and in accordance with Board of Supervisors' Policy A-30, the department will return to the Board with the appropriate budget adjustments. No additional staffing is requested to carry out the objectives of this grant.

Since the inception of the resolution, the County of Riverside has received approximately \$126,276, which has allowed agency staff to abate approximately 1,015 tons of solid wastes, 485 tons of tires, and 45 gallons of hazardous waste.

The current resolution is set to expire March 2014. Adoption of the attached resolution is the next step necessary to continue authorizing the application for a Farm and Ranch Solid Waste Cleanup and Abatement Grant for eligible properties within unincorporated Riverside County.

Impact on Citizens and Businesses

As previously stated above, the utilization of this grant will allow additional funding for the Code Enforcement Department to abate large amounts of illegal solid waste on farm and ranch properties within Riverside County improving the Health and Safety of the surrounding neighborhoods and communities.

8 WHEREAS, Public Resource Code Section 40000 et seq. authorize the
9 Department of Resources Recycling and Recovery (CalRecycle), to administer
10 various Grant programs (grants) in furtherance of the State of California's
11 efforts to reduce, recycle and reuse solid waste generated in the State
12 thereby preserving landfill capacity and protecting public health and safety
13 and the environment; and thereby preserving landfill capacity and protecting
14 public health and safety and the environment; and

15 WHEREAS, the receipt of CalRecycle Abatement Grants would increase the
16 ability of staff to either remove or abate public nuisances arising from
17 trash, rubbish and debris throughout the unincorporated areas of the county
18 of Riverside; and

19 WHEREAS, the County of Riverside Code Enforcement Department has
20 sufficient resources, technical expertise and/or experience with similar
21 projects to carry out the proposed cleanup programs to fully remediate
22 cleanup projects identified in the Grant Agreements; and

23 WHEREAS, the CalRecycle requires as a condition of application that the
24 applicant authorizes by resolution certain matters prior to the submission of
25 the Grant application;

26 WHEREAS, the County of Riverside Resolution 2009-113 is set to expire
in March 2014; and

1 NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED by the
2 Board of Supervisors of the County of Riverside, State of California, in
3 regular session on 03/25/2014, as follows:

4 1) That the Board of Supervisors hereby finds and declares that the
5 above recitals are true and correct.

6 2) That the Board of Supervisors authorizes the filing of applications
7 for the CalRecycle Abatement Grants for the period of 2014 through
8 2019.

9 3) That the Board of Supervisors has determined that delegating
10 authority to the Code Enforcement Official to execute necessary Farm
11 and Ranch Solid Waste Cleanup and Abatement Grant documents would
12 facilitate the implementation of the cleanup programs, increase
13 efficiency, and save administrative costs.

14 4) That the Board of Supervisors hereby delegates to the Code
15 Enforcement Official, or his designee, the authority and power to
16 execute in the name of the County of Riverside all necessary CalRecycle
17 Abatement Grant documents, including, but not limited to, the
18 application, the Grant Agreement, the Grant Payment Requests, and
19 amendments necessary for the purposes of securing grant funds, and for
20 the implementation and completion of the Grant projects.
