The City of Hemet has indicated their interest in contracting for fire protection services with the Riverside County Fire Department, and as such, the two agencies have reached an understanding as to the level of service to be provided to the City of Hemet. A final agreement will be submitted to the Board of Supervisors for approval once the outstanding listed issues are resolved. The transition date will be during the latter part of 2014.
