BACKGROUND:

Summary (continued)

On February 15, 2011 (M.O. 3.36) the Board of Supervisors approved Sprint Nextel Frequency Reconfiguration Agreement. During this multi-year Public Safety Enterprise Communication (PSEC) project, the Federal Communication Commission (FCC) mandated rebanding of 800 MHz frequencies due to interference from commercial radio transmitter sites – specifically Sprint Nextel.

The FCC then further discovered limitations of the 800 MHz spectrum and advised PSEC to reengineer and redesign the new radio system using 700 MHz frequency band which is reserved for public safety. As a result, Sprint Nextel was obligated to pay for Motorola reengineering expenses and expenses for the installation of the new equipment. Sprint Nextel is seeking this amendment and asking the County of Riverside confirm the completion of Motorola system reengineering and the installation of the equipment.

This amendment replaces Schedule C with Schedule C-1. Schedule C-1 is attached. As Motorola performed the rebanding work additional hardware, construction and staffing costs were incurred. Sprint Nextel has approved the additional Motorola costs and the Frequency Reconfiguration Agreement has been modified to include these costs.

Impact on Citizens and Businesses

The constituency is better served by the expanded and regionally interoperable public safety communication system deployed within the County of Riverside. In the event of any incident, large or small, Public Safety First Responders will continue to rely on an operational communication system as they serve the needs of the public.

Contract History and Price Reasonableness

This is the first amendment to the Frequency Reconfiguration Agreement and the amendment is cost neutral. The financial responsibility is with Sprint Nextel to reimburse Motorola Inc. for the work performed. Additionally, when the county rebanding effort is complete Sprint Nextel will reimburse the PSEC project for an estimated value of \$3 million.
