**BACKGROUND:**

**Summary (continued)**

On March 26, 2013 the Riverside County Board of Supervisors unanimously approved the Veterans Assistance Leadership of Riverside County (V.A.L.O.R.) program aimed at ensuring that homeless veterans receive needed resources such as housing, medical and mental health services, workforce development training and job placement assistance. The primary goal was, and continues to be, to end the travesty of homelessness amongst veterans.

In January 2014, DPSS conducted an exclusive "Point In Time" count of homeless veterans sponsored by HUD and Department of Veterans Affairs which resulted in 290 homeless veterans newly identified. With the expiration of V.A.L.O.R. at the end of March 2014, this new number indicates that there is a critical need for this effort to continue.

The Riverside County V.A.L.O.R. initiative aligns with the effort started at the federal level in 2009, when Veterans Affairs (VA) Secretary Eric Shinseki announced the goal of ending homelessness by the end of 2015. The Riverside County Board of Supervisors expects to continue to build on the progress achieved through V.A.L.O.R. and ensure that the neglect of military veterans is a thing of the past in Riverside County. Through the continuation of V.A.L.O.R, the Riverside County Board of Supervisors reaffirms the county's commitment to providing these services to it's homeless veterans.
