In 1976, Linda moved to Provincetown, Massachusetts where she was co-owner of the Pied Piper, one the few women's bars in the country. Her next "successful venture" was as owner of the Rose Tattoo in West Hollywood. In the early 1990's, she relocated to Palm Springs and became a member of the cast of the Palm Springs Follies. She also performed at the Ace Hotel as the "singing hostess of Sissy Bingo."
