
**RECOMMENDED MOTION:** That the Board of Supervisors:

**BACKGROUND:**

Jamil Dada has been a local, state and national leader in workforce development since 2004. He has served as the chairman of the National Association of Workforce Boards, the County Workforce Investment Board and vice-chair of the California Green Collar Jobs Council. Jamil has served on the California Workforce Investment Board since 2005.

He has held multiple leadership positions at Provident Bank since 1996, including vice-president and senior financial manager. He was vice-president at American Express Financial Advisors from 1986 to 1996. Jamil co-chairs the City of Riverside's Council of Economic and Workforce Advisors. He serves on several Board and Commissions related to March Air Reserve Base, the nation's largest reserve base. He serves as Chairman of the March Field Air Museum. At Riverside Community College District, Jamil serves as a Board member of the district's Foundation. Jamil is also past chairman of the Moreno Valley Chamber of Commerce, vice-president of the community Assistance Program (a food pantry) and a member of former Congresswoman Mary Bono-Mack's military academy selection committee.
