[\$1,587,825 – 79% Contract Revenue & 21% General Fund]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the FY 2013-14 rate of \$0.0365 per transaction for access to the Sheriff's Records Management System (RMS).

BACKGROUND:

Summary

The Sheriff's Department implemented the RMS in February 1999. The RMS provides a participating agency the ability to enter cases and query case histories, to access the Master Name Index, Warrants, Master Location Index and Jail Locator databases. Local law enforcement, contract cities, County, State and Federal agencies are using the System under contract with the Sheriff's Department. In FY 2012-13, the Board approved a RMS rate of \$0.0502 per transaction (05/14/13 3.23).

BACKGROUND:

Summary (continued)

The proposed rate calculation was based on a review of recoverable FY 2012-13 expenditures to arrive at a FY 2013-14 RMS base cost of \$1,587,825. This composite estimate was then divided by the estimated FY 2013-14 transaction count of 43,505,940. The resulting quotient of \$0.0365 is charged to City Police Departments and County, State and Federal agencies. An estimated \$96,698 of the RMS base cost will be recovered from these allied agencies. Then, based on calendar year 2012 call data, 93.91% of the RMS cost or \$1,156,831 is distributed to the County unincorporated areas and the contract cities based on the number of calls originating from each area. The Department estimates a total of \$1,253,529 in revenues to offset RMS expenses.

The FY 2013-14 base RMS cost decreased by -\$245,352 or approximately -13.4% from the last fiscal year's cost. The primary contributor to this was the decrease in cost for computer lines charged by RCIT and software maintenance fees.

Impact on Citizens and Businesses

The Records Management System provides all participating agencies access to the Master Name Index, Warrant System, Master Location Index, Jail Locator Database and the California Law Enforcement Telecommunication System (CLETS). Access to RMS provides one shared database for agencies to enter and query case histories to obtain criminal history information.
