ORDINANCE NO. 452.235 AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 452 RELATING TO PRIMA FACIE SPEED LIMITS

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 2.2 of Ordinance No. 452, entitled "Thirty miles per hour," is hereby amended to add new subsections 24, 25, and 26 to read as follows:

24. On Mayberry Avenue between San Jacinto Street and Cornell Street, a total distance of approximately 1.00 miles, in the Hemet area.
25. On Olivas Avenue between Central Avenue and Nuevo Road, a total distance of approximately 0.5 miles, in the Nuevo area.
26. On Olivas Avenue between San Jacinto Avenue and a point 320 feet north of Cobblestone Street, a total distance of approximately 0.34 miles, in the Nuevo area.

Section 2. Section 2.3 of Ordinance No. 452, entitled "Thirty-Five miles per hour," is hereby amended to add new subsections 119, 120 and 121 to read as follows:

119. On Bell Avenue between 11th Street and Wolfskill Avenue, a total distance of approximately 0.5 miles, in the Nuevo area.
120. On Church Street between Polk Street and Grapefruit Boulevard, a total distance of approximately 0.5 miles, in the Thermal area.
121. On Mayberry Avenue between Cornell Street and Lake Street, a total distance of approximately 1.5 miles, in the Hemet area.

Section 3. Section 2.4 of Ordinance No. 452, entitled "Forty miles per hour," is hereby amended to add new subsection 140 to read as follows:

140. On the easterly half of Van Buren Street between 48th Avenue and Manila Avenue, a total distance of approximately 0.25 miles, in the Indio area.

Section 4. Section 2.5 of Ordinance No. 452, entitled "Forty-Five miles per hour," is hereby amended to add new subsections 158, 159, 160, and 161 to read as follows:

158. On Box Springs Mountain Road between a point 1,300 feet west of Running Gun Lane and Pigeon Pass Road, a total distance of approximately 0.5 miles, in the Moreno Valley area.
159. On McAllister Street between El Sobrante Road and a point 400 feet south of Sierra Heights Drive, a total distance of approximately 1.5 miles, in the Lake Mathews area.
160. On Monte De Oro Road between Rancho California Road and Aranda Street, a total distance of approximately 1.5 miles, in the Temecula area.
161. On San Jacinto Avenue between Pico Avenue and Menifee Road, a total distance of approximately 0.5 miles, in the Nuevo area.

Section 5. Section 2.6 of Ordinance 452, entitled "Fifty miles per hour," is hereby amended to add new subsections 72, 73 and 74 to read as follows:

72. On Contour Avenue between Citrus Street and Juniper Flats Road, a total distance of approximately 0.78 miles, in the Nuevo area.
73. On the full width of Pigeon Pass Road between Box Springs Mountain Road and a point 1,300 feet north of Hidden Springs Drive; and on the westerly half between a point 1,300 feet north of Hidden Springs Drive and Hidden Springs Drive, a total distance of approximately 0.9 miles, in the Moreno Valley area.
74. On the full width of Van Buren Boulevard between King Avenue and Gamble Avenue and the northerly half of Van Buren Boulevard between Gamble Avenue and Dauchy Avenue, a total distance of 1.8 miles, in the Woodcrest area.

Section 6. Subsection 2 of Section 2.7 of Ordinance 452, entitled "Fifty-five miles per hour," is hereby amended to read as follows:

27. On Van Buren Boulevard between a point 1,500 feet west of Barton Road to a point 338 feet of the centerline of I-215, a total distance of approximately 7.01 miles; and between the Riverside city limits (a point 530 feet west of Pine Court) and King Avenue, a total distance of approximately 2.7 miles, in the Woodcrest area.

Section 7. Section 3.4 of Ordinance No. 452, entitled "Fifteen miles per hour," is hereby amended to add new subsection 1 to read as follows:

1. On the dirt segment of Box Springs Mountain Road between a point 1,300 feet west of Running Gun Lane to a point 4,468 feet west of Running Gun Lane, a total distance of approximately 0.6 miles, in the Moreno Valley area.

Section 8. Section 3.6 of Ordinance No. 452, entitled "Twenty-five miles per hour," is hereby amended to add new subsection 2 to read as follows:

2. On the dirt segment of Olivas Avenue between a point 320 feet north of Cobblestone Street and Central Avenue, a total distance of 0.16 miles, in the Nuevo area.

Section 9. Subsection 14 of Section 2.3 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 14 of Section 2.3 established a thirty-five miles per hour speed limit on Mayberry Avenue between San Jacinto Street and Lake Street pursuant to Ordinance No. 452.214 adopted by the Board on February 4, 2003.

Section 10. Subsection 86 of Section 2.3 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 86 of Section 2.3 established a thirty-five miles

Street between Van Buren and Washington Streets pursuant to Ordinance No. 452.222 adopted by the Board on April 18, 2006.

Section 11. Subsection 17 of Section 2.6 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 17 of Section 2.6 established a fifty miles per hour speed limit on Van Buren Boulevard between the centerline of Washington Street and the centerline of Wood Road pursuant to Ordinance No. 452.214 adopted by the Board on February 4, 2003.

Section 12. Subsection 18 of Section 2.7 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 18 of Section 2.7 established a fifty-five miles per hour speed limit on McAllister Street between the centerline of El Sobrante Road and the centerline of Orangehaven Lane pursuant to Ordinance No. 452.225 adopted by the Board on June 2, 2009.

Section 13. This ordinance shall take effect 30 days after its adoption.
