BACKGROUND:

Summary

The Riverside County Department of Environmental Health has been designated the Local Enforcement Agency (LEA) by the State agency Cal-Recycle. The LEA is responsible for the permitting, inspection and enforcement of certain waste facilities within its jurisdiction. Cal Recycle will disburse grant funds state-wide to supplement LEA's existing budget for equipment, supplies, training, personnel and technical support.

RESOLUTION NO. 2014-108

A RESOLUTION OF THE COUNTY OF RIVERSIDE AUTHORIZING THE DEPARTMENT OF ENVIRONMENTAL HEALTH TO APPLY AND ACCEPT LOCAL ENFORCEMENT AGENCY GRANT FUNDS

WHEREAS, the State Public Resources Code sections 40000et seq. authorize the Department of Resources Recycling and Recovery (Cal Recycle) to administer various grant programs in furtherance of the State of California (State) efforts to reduce, recycle, and reuse solid waste generated in the State, thereby preserving landfill capacity and protecting public health and safety and the environment; and

WHEREAS, in furtherance of this authority Cal Recycle is required to establish procedures governing the application, awarding, and management of the grants; and

WHEREAS, Cal Recycle grant application procedures require, among other things, an Applicant's governing body to declare by Resolution certain authorizations related to the administration of Cal Recycle grants.

NOW THEREFORE, BE IT RESOLVED that the Riverside County Board of Supervisors authorizes the submittal of application(s) to Cal Recycle for the Local Enforcement Agency grant and has been delegated the responsibility for administering the LEA Grant, which includes procedures governing the application by and payment of grant funds to LEAs ; and

BE IT FURTHER RESOLVED that the Director of the Riverside County Department of Environmental Health, or his/her designee is hereby authorized and empowered to execute in the name of Riverside County Department of Environmental Health LEA all grant documents, including but not limited to, applications, agreements, amendments and requests for payment, necessary to secure grant funds and implement the approved grant project; and

BE IT FURTHER RESOLVED that these authorizations are effective for five (5) years from the date of adoption of this Resolution (through FY 18/19) Director of the Riverside County Department of Environmental Health.


