BACKGROUND:

Summary (continued)

In February 2013, the Board approved an agreement with CherryRoad Technologies to assist in upgrading the County's financial system software. Although the upgrade was successfully completed in April, subsequent technical modifications were required to add vendor patches and updates, which occurred during the installation. These additional adjustments are a normal process following an upgrade of this nature; however, latency and other performance issues are being encountered and could not have been anticipated. These issues are impacting the County's ability to issue vendor payments and other routine accounting / purchasing processes and require immediate resolution, particularly as year-end administrative and accounting activities are at their peak.

CherryRoad is skilled in PeopleSoft configuration / system tuning and possesses the specific subject matter expertise required to address the current performance issues.

Impact on Residents and Businesses

This application not only impacts internal County agencies and staff, but also the external vendors and customers of the financial system.

SUPPLEMENTAL:

Additional Fiscal Information

On February 5, 2013 (M.O. 3-44), the Board approved the \$220,000 professional service agreement with CherryRoad Technologies, Inc., for services through February 4, 2014. On February 4, 2014 Purchasing Fleet Services exercised an extension of the contract through February 4, 2015.

Contract History and Price Reasonableness

The professional service was competitively bid via a Request for Quote (ITARC-150) and awarded to CherryRoad Technologies, Inc., in the amount of \$220,000. CherryRoad has extended the contract pricing for this requested amendment, in the amount of \$80,000.
