Summary

FISCAL PROCEDURES APPROVED

The Commission on Peace Officer Standards and Training (POST) funded the purchase of a driving simulator and a force options simulator with the understanding that the Sheriff's Department would provide training to full-time, on-duty law enforcement officers (4/18/00 3.31). POST partially reimburses the County for each officer that attends the training courses. In addition, POST reimburses the County to train its own instructors for the courses.

# BACKGROUND:

# Summary (continued)

Pursuant to the proposed FY 2014-15 POST Agreement, BCTC will train 33 students in the 24-hour Driving Simulator Instructor course at a cost not to exceed \$480.17 per student, for a total course cost of \$15,845.61.

BCTC will also train 34 students in the 40-hour Force Option Simulator Instructor course at a cost not to exceed \$721.67 per student, for a total course cost of \$24,536.78. The maximum amount that the Sheriff's Department can bill POST for this service is \$40,382.39. The POST reimbursement revenue is in the Sheriff's Department proposed FY 2014-15 budget. County Counsel has approved the POST Agreement as to form.

# Impact on Citizens and Businesses

The two simulator training courses fulfill eight hours of the 24 hours of POST mandated perishable skills training required biennially of California peace officers employed by a POST-certified agency. Training department staff members as instructors saves the cost for independent instructors and keeps the presentation of the courses at the training center, which saves the County student travel and possible lodging expenses.

# EXHIBIT A (Standard Agreement)

### **SCOPE OF WORK**

The Riverside County Sheriff's Department (Contractor) agrees to provide for the Commission on Peace Officer Standards and Training (POST) Driving and Force Option Simulator Instructor Training to qualified law enforcement personnel.

- 1. Each course presentation shall be certified by POST and presented in accordance with content provided by POST.
- 2. Contractor agrees to train up to:
  - Thirty-three (33) students in the 24-hour Driving Simulator (LEDS) Instructor Course at a per student rate of \$480.17.
  - Thirty-four (34) students in the 40-hour Force Option Simulator (FOS) Instructor Course at a per student rate of \$721.67.
- 3. In the event there are not enough students from POST reimbursable agencies to fill any class, the Contractor may opt to fill vacancies with students who are not full-time instructors from POST reimbursable agencies. Students attending the course who are non-reimbursable under POST regulations shall be charged applicable course tuition, as referenced above, by the Contractor. Prior to submission of an invoice to POST, Contractor shall deduct, from the total sum, the amount collected for tuition. The invoice shall clearly reflect where the collected tuition has been deducted. Invoices for payment shall be submitted in accordance with the terms specified in the applicable contracted course.



# EXHIBIT B (Standard Agreement)

# **BUDGET DETAIL AND PAYMENT PROVISIONS**

#### 1. Invoicing and Payment

A. The total amount POST may pay the Contractor under this Agreement for services satisfactorily rendered, and upon receipt and approval of the invoices, shall not exceed the Contract Amount of \$40,382.39, as set forth in this Exhibit.

For services satisfactorily rendered, and upon receipt and approval of the invoices, the State agrees to compensate the Contractor at the end of each course, a per student rate, for the actual number of reimbursable students attending the course:

- LEDS Instructor Course at a per student rate of \$480.17.
   (Estimated number of reimbursable students = 33 x \$480.17 = \$15,845.61)
- FOS Instructor Course at a per student rate of \$721.61.
   (Estimated number of reimbursable students = 34x \$721.67 = \$24,536.78)
- B. Upon completion of each presentation, Contractor agrees to submit the following before payment will be authorized:
  - Agreement Number
  - Course Title
  - Course Roster/s
  - An invoice totaling the number of full-time, on-duty POST reimbursable students who attended the presentation.
  - Authorized rate per student
  - Dates of Course presented

# 2. Budget Contingency Clause

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either cancel this Agreement with no liability occurring to the State, or offer an agreement amendment to Contractor to reflect the reduced amount.

### 3. Prompt Payment Clause

Payment will be made in accordance with, and within the time specified in, Government Code Chapter 4.5, commencing with Section 927.

# EXHIBIT D (Standard Agreement)

# **SPECIAL TERMS AND CONDITIONS**

#### 1. Settlement of Disputes

Except as otherwise provided in this agreement, any dispute concerning a question of fact arising under this agreement which is not disposed of by compromise shall be decided by POST, who shall reduce its decision in writing and mail or otherwise furnish a copy thereof to Contractor. Contractor has fifteen (15) calendar days after receipt of such a decision to submit a written protest to POST specifying in detail in what particulars the agreement requirements were exceeded. Failure to submit such a protest within the period specified shall constitute a waiver of any and all right to adjustment in agreement terms and POST's decision shall be final and conclusive. Pending final decision of a dispute hereunder, Contractor shall proceed diligently with the performance of this agreement, upon receipt of written order from POST to do so.

#### 2. Amendments

This agreement may be amended for time, scope or increase/decrease of funds, by mutual written consent.

#### 3. Cancellation Clause

POST reserves the right to cancel this agreement subject to 30 days written notice to Contractor.

### 4. Contractor Evaluation (if applicable)

In accordance with provisions of the State Administrative Manual, Section 1283, Contractor's performance under this agreement will be evaluated. The evaluation will be prepared by POST within 30 days after completion of the agreement.
