BACKGROUND:

On April 22, 2014, the Board of Supervisors approved the conduct of election services for the Consolidated Primary Election. This election includes both federal and state offices and elections for certain local jurisdictions. The County will not be reimbursed for federal and state offices but local jurisdictions that have added a measure or special election to the June ballot will reimburse the Registrar of Voters for the full cost of conducting their election. Election costs fully reimbursable from local jurisdictions is approximately \$900,000.

The election was held on June 3, 2014 with 22.32% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the Consolidated Primary Election.

Impact on Citizens and Businesses

Registered voters who reside in the County of Riverside had the opportunity to elect candidates for federal and state offices and local jurisdiction offices.

Additional Fiscal Information

As approved by the Board of Supervisors on April 22, 2014, local jurisdictions that have added a measure or special election to the June ballot will reimburse the Registrar of Voters for the full cost of conducting their election.

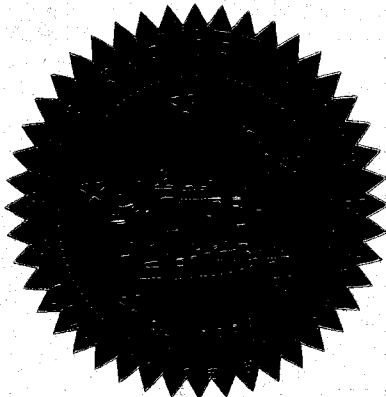
