



BACKGROUND: CONTINUED:

1. **Anza Valley Christian Men's Club- \$2,500-** This program is for distribution of the monthly United States Department of Agriculture Food Distribution Project. USDA food is picked up from Food In Need of Distribution (F.I.N.D.) program in the desert and brought to Anza for distribution to Anza and Aguanga residents.
2. **Debbie Chisholm Memorial Foundation- \$2,500-** provides wishes granted to sick or abused children, this year DCMF will grant wishes to the children who reside at Rancho Damacitas Treatment and Foster Care Agency in Temecula.
3. **City of San Jacinto -\$500-** will provide summer concert series at the City of San Jacinto historic Estudillo Mansion located in the Estudillo Heritage Park.
4. **The Riverside Area Rape Crisis Center- \$1,500-** funding will be used for direct services and community education programs.
5. **Manzanita Ranch- \$2,500-** In partnership with the City of Temecula Manzanita Ranch will bring a five day display of the Vietnam Memorial "The Moving Wall" in Temecula the first of October. The project is to honor Vietnam Veterans and bring awareness to the veterans of Vietnam War and to offer some first-hand history education to area youth.
