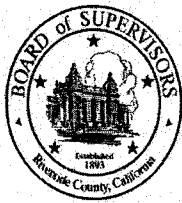





BACKGROUND: CONTINUED:

1. **Friends of the San Jacinto Mountain County Parks- \$500-** Lemon Lily Festival and Restoration Project the funds will aid in the propagation of the liliium parryi, a threatened native species. The goals are to collect and distribute seeds from the established plants, purchase bulbs from indigenous stock and to grow plants in specialized medium under best practice conditions to aid in the restoration of the lily.
2. **Anza Baptist Church-\$1,500-** The project is the ABC Community Food Pantry and it will provide emergency food assistance to the needy families located within the Anza / Aguang area.
3. **Hospice of the Valleys- \$2,500—**provides much needed medications, equipment and bereavement services for families with no insurance coverage.
4. **Mountain Disaster Preparedness- \$3,000-** to provide monthly Tri-Level training classes and exercises that complement the CERT training for Mountain Disaster Preparedness volunteers as well as training materials and uniforms.
5. **Temecula-Murrieta Community Pantry- \$5,000-** to provide emergency food and personal hygiene products for families. In addition, the funding will assist with holiday fresh food items.
