BACKGROUND:

Summary

On June 22, 2010, the Board of Supervisors approved three separate General Fund loans for the establishment of Economic Development Agency (EDA) Custodial, Maintenance, and Real Estate Internal Service funds totaling \$3,692,091. The Maintenance and Custodial funds have yet to establish sufficient cash reserves to repay their portion of the general fund.

BACKGROUND:

Summary (Continued)

Rates for services provided have not increased in over 7 years in support of the economic hardship that the many county departments are facing. Consequently, developing sufficient cash reserves for these two funds will continue to prove challenging in the next few years. Every effort has been made to repay the loan while still providing adequate services that meet health and safety standards. An extension is being requested to continue to operate and provide the necessary services needed to county departments. EDA will continue to operate within current policy standards set for revenue generation for our agency and will need more time to repay this loan in the amount of \$3,342,091. EDA will work with the Executive Office to repay the general fund loan prior to FY 2019/20.

Impact on Citizens and Businesses

The Maintenance and Custodial Services Divisions provide critical services to all county owned buildings that allow the community access to county services.
