BACKGROUND:

SUMMARY

County of Riverside Department of Public Health (DOPH) has been contracting with California State University San Bernardino for student affiliation since 2002 with annual renewals. California State University San Bernardino desires to establish an amendment for contracting with the County of Riverside Department of Public Health for five years in order to evade the intense procedures involved in renewing the agreement annually.

The agreement provides for the assignment of students enrolled in the University's nursing and vocational nursing programs to County Public Health Programs. The students provide the County with valuable assistance at no cost. In addition, the students gain much needed on-the-job training and experience. The assigned students provide an excellent source of recruitment.

California State University, San Bernardino has requested to extend the term of the agreement to June 30, 2019. This amendment will amend the performance period from July 1, 2013 through June 30, 2014 to July 1, 2014 through June 30, 2019.

Impact on Citizens and Businesses

Due to the critical nursing shortage, the schools of nursing have been working to increase the number of students. The DOPH is working with the Nursing Schools to expand the number of students allowed in an ongoing effort to increase the pool of nurses in Riverside County.

Contract History

On November 8, 2013, the Riverside County Purchasing Agent signed a no money agreement # 14-011 with California State University San Bernardino for the performance period of July 1, 2013 through June 30, 2014.

FIRST AMENDMENT TO THE AGREEMENT

BETWEEN

(Student Affiliation)

That certain Agreement between the County of Riverside Department of Public Health (COUNTY) and California State University San Bernardino (UNIVERSITY), approved on November 8, 2013, is hereby amended for the first time effective July 1, 2014 as follows:

- Amend all references to the period of performance from July 1, 2013 through June 30, 2014 to July 1, 2014 through June 30, 2015.
- All other terms and conditions of this Agreement are to remain unchanged.
