

BACKGROUND: CONTINUED:

- 1. St. Caries Center for Human Development- \$500-** will assist with St. Caries Center SMART organic garden. The garden provides students with a safe place to go afterschool and an opportunity to learn science, technology, engineering, math, STEM. It offers character development and teaches teamwork. It fosters employment skills for the high school cross-age tutors and prevents children from engaging in negative activities.
- 2. The Associates of the Idyllwild Arts Foundation-\$2,000-** Sponsorship of the Idyllwild Arts Academy, Jazz in the Pines Festival which benefits the academy's summer programing. Students study music, fine arts, writing and dance at the academy. In addition, the festival is a strong economic driver for local businesses in the Idyllwild area.
- 3. Community Connect- \$1,000-** Sponsorship for the 17th annual non-profit conference that supports our non-profit partners by providing affordable, local educational opportunities. Non-profits need to operate efficiently and in sustainable manner in order to provide the important health and human services that all communities benefit therefrom.
- 4. California Family Life Center, Kin Care Program - \$1,500-** provides direct support services to families. Assisting relative caregivers by promoting permanency, including kinship adoption and guardianship. Family case management activities have allowed for staff to provide a variety of result-oriented services in an effort toward stabilization and permanency for children.
