

BACKGROUND: CONTINUED:

1. **Diamond Valley Arts Council- \$1,500-** Team music program provides music education and performance so students will learn creativity through music, and engagement in the artistic environment, will be a motivation for the adolescents to choose a positive lifestyle during and after their participation in the program.
2. **The Humanity of Justice Foundation- \$2,000-**Funding will provide emergency shelter for children and mental health services to parents and neglected children.
3. **Anza Electric Cooperative, Inc.- \$1,000-** Funding will be used for the Cooperative Care Program to assist area residents with utility bills, food, well repairs.
