BACKGROUND:

Summary

According to Government Code Section 29321.1, the County Auditor shall render a written report to the Board of Supervisors at the end of each fiscal year identifying revolving funds in existence during the fiscal year, the amount of each fund, and the officer using the fund.

As of June 30, 2013, the total balance of revolving funds was \$1,467,903 compared to a June 30, 2014 balance of \$798.221. The difference of \$669,682 is due to the establishment and discontinuance of revolving fund accounts, as well as fluctuations of balances based on the need in the revolving fund. During Fiscal Year 2014, revolving fund accounts for Northwest Mosquito & Vector Control District and Coachella Valley Mosquito & Vector Control District in the amount of \$542,000 and \$267,922 respectively were discontinued which had a significant impact on the total balance of revolving funds as of June 30, 2014.
