RCRMC and University of California, Riverside School of Medicine (UCR) and its Faculty Practice (UCRFP) are embarking on a new relationship. UCR operates medical residency and medical student training programs and UCRFP provides a faculty practice program the purpose of which is to provide community and/or direct patient care services, establish clinical sites for student education and/or pursue research and leadership opportunities. Through this regional cooperation agreement, UCR and UCRFP will serve as a resource to RCRMC for joint education and training of health professionals and provide technical assistance and consultation to RCRMC staff. This agreement formalizes the arrangement between the RCRMC, UCR and UCRFP to grow and manage certain clinical service lines provided at RCRMC, including its inpatient, ambulatory and federally qualified health centers look-alikes (FQHC). Clinical service lines to be provided include internal medicine, family medicine, cardiology (non-invasive) and general surgery.

Per the terms of the agreement, UCR and UCRFP shall be responsible for, but not limited to; 1) provision of appropriately qualified attending physicians who are responsible for both care provisions and oversight of residents and medical students; 2) recruitment, orientation, management and discipline of attending physicians; 3) provision of billing services and compensation of attending physicians; 4) referral of patients to RCRMC diagnostic and therapeutic services; 5) ensuring compliance with all federal, state rules and regulations and other applicable agencies laws, statutes, rules and regulations; 6) each physician shall be accountable to both the designated UCR Chair and RCRMC Chair for their performance and other patient care metrics; and, 7) measuring and reporting progress toward patient care and budgeted financial performance goals and objectives.

In addition, UCR and UCRFP will be jointly responsible with Loma Linda University School of Medicine (LLUSM) and its faculty practice for growing and managing cardiology (non-invasive) and gastroenterology; and with Western University School of Health Science (Western) for anesthesiology and orthopaedics. Agreements between the County and LLUSM, and the County and Western will be submitted separately for Board consideration.

Financial Impact

There are no costs associated with the regional cooperation agreements.

REGIONAL COOPERATION AGREEMENT

This Agreement is made by and between the County of Riverside (COUNTY), a political subdivision of the State of California on behalf of the Riverside County Regional Medical Center (hereinafter "RCRMC"), University of California Riverside School of Medicine (hereinafter "UCR"), a California public school of medical education, and its Faculty Practice (hereinafter "UCRFP"), collectively referred to as "the Parties."

RECITALS

- A. RCRMC is a licensed hospital under the laws of the United States and the State of California as a General, Acute Care Hospital that operates an General Acute Care Unit, Intensive Care Unit, Perinatal Care Unit, Intensive Care Newborn Unit, Emergency Care Services Ambulatory Care Services, Acute Psychiatric and General Pediatric Services.
- B. UCR operates medical residency and medical student training programs in compliance with all applicable laws and regulations.
- C. UCR is a California public University pursuant to the laws of the State of California. UCR employs clinical faculty in the areas of Internal Medicine, Family Medicine, General Surgery, Cardiology, and Obstetrics & Gynecology for a faculty practice program. RCRMC and UCR therefore agree as follows:

TERMS AND CONDITIONS OF AGREEMENT

- 1. UCR and UCRFP shall provide Regional clinical affiliation to RCRMC upon the terms and conditions set forth in this Agreement.
- 2. UCR and UCRFP will serve as a resource to RCRMC for joint education and training of health professionals. A staff member will be appointed as a primary liaison between

UCR, UCRFP and RCRMC for the services specified in this Agreement. In addition, additional liaison personnel will be appointed as needed to coordinate activities between the Parties for each service listed in Exhibit A.

3. Guidelines for Consultation

UCR and UCRFP will provide technical assistance and consultation to RCRMC staff concerning UCR and UCRFP services and requirements.

4. <u>Annual Policy and Data Review</u>

Authorized UCR, UCRFP and RCRMC representatives shall meet annually not later than six (6) months after the effective date of this Agreement to identify, preview and develop their policies, procedures and protocols related to the provisions of this Agreement and to jointly review performance data regarding management of clinical services lines as outlined in Exhibit A.

6.0 TERM AND RENEWAL AND AMENDMENT

A. TERM. The term of this Agreement shall become effective on July 1, 2014 and shall remain in effect for an initial term of ten years unless earlier terminated by either party as set forth below. Thereafter, this Agreement shall renew upon the execution of an amendment, on the same terms and subject to the same conditions.

- B. TERMINATION WITHOUT CAUSE. Any party may terminate this

 Agreement without cause by providing the other party with twelve months prior written notice of termination. Termination shall take effect automatically upon expiration of the twelve month notice period.
- C. TERMINATION WITH CAUSE. This Agreement shall terminate immediately, in the event of the occurrence of the following:
- a. Revocation, suspension or restriction of the PARTIES licenses, accreditation or certification required for the performance of the duties hereunder.
 - b. Parties failure to provide Services as provided herein.

7. **Indemnification**

This shall include, but not be limited to, payment of all attorney fees, defense costs and settlements or award.

UCR and UCRFP shall be responsible for growing and managing the following clinical

services lines provided at Riverside County Regional Medical Center (RCRMC), including its inpatient, ambulatory and federally qualified health centers (FQHC): Internal Medicine, Family Medicine, Cardiology (Non-Invasive) and General Surgery. Responsibility for these clinical services lines shall include, but not be limited to: 1) provision of appropriately qualified (i.e. current board certification or active candidate in the examination process) attending physicians who are responsible for both care provision and oversight of residents and medical students within these clinical service lines to meet the demand for inpatient and ambulatory based consultative evaluation and management services, diagnostic testing, and therapeutic procedures and/or treatments in accordance with current care standards; 2) recruitment, orientation, management and discipline of appropriately qualified (i.e. current board certification or active candidate in the examination process) attending physicians; 3) provision of billing services for and compensation for these attending physicians; 4) referral of patients to RCRMC's diagnostic and therapeutic services, unless these services do not exist and/or are unavailable for use; 5) ensuring compliance with all Federal, State rules and regulations and other applicable agencies laws, statutes, rules and regulations; 6) each physician shall be accountable to both the designated UCR Chair responsible for that service line and RCRMC Chair for their performance and other patient care metrics as so determined from time to time by RCRMC in collaboration with UCR; and 7) measuring and reporting progress toward patient care and budgeted financial performance goals and objectives monthly to RCRMC,
