RECOMMENDED MOTION (continued):

- 3. The owners be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- 4. If the owners, or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owners or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, may abate the substandard structure and contents therein, by removing the same from the real property.
- 5. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Ordinance No. 725.
- 6. County Counsel be directed to prepare the necessary Findings of Facts and Conclusions that the substandard structure on the real property is declared to be in violation of Riverside County Ordinance No. 457 and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An initial inspection was made on the subject property by Code Enforcement Officer Carol Forrey on November 20, 2012. The inspection revealed substandard structure (garage) on the subject property in violation of Riverside County Ordinance No. 457. The substandard conditions of the structure included, but were not limited to, the following: hazardous plumbing, hazardous wiring, members of walls, partitions or other vertical supports that split, lean, list or buckle due to defective material or deterioration, members of ceilings, roofs, ceiling and roof supports or other horizontal members which sag, split, or buckle due to defective material or deterioration, general dilapidation or improper maintenance, extensive fire damage, public and attractive nuisance abandoned/vacant.
- 2. There have been six subsequent follow up inspections with the last inspection occurring on May 23, 2014 which revealed the property continues to be in violation of Riverside County Ordinance No. 457.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for substandard structure.

- I, Jacob Dietrich, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:
- I am currently employed by the Riverside County Code Enforcement Department as a 1. Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and thereon allege that on November 20, 2012, Officer Forrey conducted an initial inspection of the real property described as 44508 Buntin Way, Hemet, Riverside County, California, and further described as Assessor's Parcel Number 548-052-045 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by The Estate of Robert Staich and Danilo Staich (hereinafter referred to as "OWNERS"). A certified copy of the County Equalized Assessment Roll for the 2013-2014 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B"
- 4. Based on the Lot Book Report from RZ Title Service dated August 6, 2013 and updated on March 17, 2014 it is determined that other parties may potentially hold a legal interest in THE PROPERTY, to wit: Robert Staich, Charlotte Staich, Charlotte Staich-Yohncke, and Pamela H.C. Staich, (hereinafter referred to as "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by reference as Exhibit "C."

- 12. Based upon my experience, knowledge and visual observations, it is my determination that the substandard structure (garage) on THE PROPERTY creates an extreme health, safety, fire and structural hazard to the neighbors and general public.
- 13. A recent inspection showed THE PROPERTY remained in violation and constitutes a public nuisance in violation of the provisions set forth in RCO No. 457.
- A Notice of Pendency of Administrative Proceedings was recorded in the Office of the 14. County Recorder, County of Riverside, State of California, on August 21, 2013, as Instrument Number 2013-0410764, a true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F."
- 15. A Notice to Correct County Ordinance Violations and Abate Public Nuisance, providing notification of the Board of Supervisors' hearing was mailed to OWNERS and INTERESTED PARTIES by first class mail and was posted on THE PROPERTY. True and correct copies of the Notice, together with Proof of Service and the Affidavit of Posting of Notice are attached hereto and incorporated herein as Exhibit "G."
- 16. Significant rehabilitation, or demolition and removal of the substandard structure and removal and disposal of all structural debris are required to abate the public nuisance and bring THE PROPERTY into compliance with RCO No. 457, the Health and Safety, Uniform Housing, Administrative and Abatement of Dangerous Buildings Codes.
 - 17. Accordingly, the following findings and conclusions are recommended:
- the structure (garage) be condemned as substandard building, public and (a) attractive nuisance;
- (b) the OWNERS be required to rehabilitate or demolish said structure, including the removal and disposal of all structural debris and materials, on THE PROPERTY in accordance with the provisions of RCO No. 457;
- the OWNERS be ordered to ascertain the existence or non-existence of asbestos (c) containing materials in said structure by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in subsection (b) above, to secure the removal and disposal of all asbestos

10	(e) that reasonable costs of abatement, after notice and opportunity for hearing, shall
11	be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against
12	THE PROPERTY pursuant to Government Code Section 25845 and RCO Nos. 457 and 725.
