RCRMC 2014/2015 Budget Update and Performance Improvement 10 Month Report

RCRMC was in financial distress during Fiscal 2013/2014:

- 1 Cash losses were approximately \$1million per week in November.
- 2 Total Cash owed to Riverside County Treasury was \$85 million in January.
- 3 Total Cash owed June 30 was down to \$40 million.

2014 / 2015 RCRMC Budget is Balanced!

- 1 Expected expenditures equal \$435 million. Huron initiated performance improvements in labor and non-labor costs exceed \$51 million.
- Expected revenue also equals \$435 million.
 Monthly cash collections are running over \$20 million; up from \$14 million in November.
 Huron initiated revenue cycle is responsible for this improvement.

Challenges facing RCRMC as we enter 2014/2015:

- 1 Revenue is extremely dependent on Government subsidies (\$200 million in 2014/2015); and improved payor mix.
- 2 Recent court action on prisoner health likely increases our hospital's need to serve.
- 3 Mental Health care is a developing issue.

Challenges facing RCRMC as we enter 2014/2015 (cont.):

- 4 –Our clinics need to improve their patient care throughput.
- 5 Critical equipment faces end of life issues at RCRMC. We will come to the Board with a request to invest \$10 million in critical equipment replacement during 2014/2015.
- 6 –RCRMC needs to hire a permanent hospital CEO and CFO.
