

California resource conservation districts (RCDs) are established, governed and authorized under Division 9 of the Public Resources Code. RCDs work to conduct:

- Watershed planning and management
- Water conservation, quality protection and enhancement
- Agricultural land conservation
- Wetland and wildlife conservation and habitat enhancement
- Recreational land restoration
- Conservation education

The next CVRCD director's meeting is scheduled for Wednesday, September 17. The acting board chairman of the CVRCD has requested that the board of supervisors act expeditiously to immediately appoint new members to fill the recent vacancies to ensure the continuation of critical district operations.

Two qualified candidates have applied to fill the vacancies, Buford Crites and Joseph Pradetto.

Buford Crites is the chairman of the Coachella Valley Mountains Conservancy, a board member of the Colorado River Regional Water Quality Control Board and a consultant for the South Coast Air Quality Management District. He is well respected within the community dedicated to preserving our natural resources and will make an excellent addition to the CVRCD Board of Directors.

Joseph Pradetto serves as a board assistant on my staff. He also serves on the Desert Healthcare District's Program Committee and the City of Palm Desert's Audit and Finance Committee. In recognition of his work in the community, Palm Springs Life recently named him one of the "40 under 40" for 2014. He understands the role of the district, its governing laws and its importance to preserving the Coachella Valley's natural resources. His particular interest is in water conservation, and I recommend his appointment.
