Plaintiffs Dr. Jozsef Debreczeni and Mary Ann Rabin, Trustee for the Bankruptcy Estate of E. Kenneth Koos (collectively "the Plaintiffs") and Defendants Thomas E. Storms, aka Eugene Storms, aka Gene Storms ("Storms") and Pangaea Consortium ("Pangaea"), hereby agree that judgment may be entered as follows:

- 1. The Court's previous ruling on February 12, 2004 is incorporated herein.

 However, the Plaintiffs specifically reserve their appeal rights regarding the entry of summary judgment in favor of Berkshire Halifax Corporation, Kenneth E. Brown and Robert A. Adams and any other assignments of error that may exist in this proceeding.
- 2. The preponderance of the evidence establishes that Plaintiffs are entitled to judgment against Storms and Pangaea under Counts I, II, III, IV, V and VIII of Plaintiffs'

Complaint, judgment already having been rendered against Storms under Counts
VI and VII of Plaintiffs' Complaint.

- 4. Judgment is hereby rendered in favor of Plaintiff Dr. Jozsef Debreczeni against Storms and Pangaea, jointly and severally, in the amount of Two Hundred Thousand Dollars (\$200,000.00).
- 5. Judgment is hereby rendered in favor of Plaintiff Mary Ann Rabin, Trustee for the Bankruptcy Estate of E. Kenneth Koos against Storms and Pangaea, jointly and severally, in the amount of Two Hundred Thousand Dollars (\$200,000.00).
- 6. Plaintiffs shall take no action to execute upon this judgment against Storms, other than transferring the judgment to the State of California or elsewhere and filing judgment liens, for one hundred eighty (180) days from the date of the entry of this judgment in the Cuyahoga County Court of Common Pleas. After the expiration of same 180-day period, Plaintiffs may execute against Storms if a balance under this judgment remains owing.
- 7. If judgment is paid in full within one hundred eighty (180) days of entry, no interest shall be assessed. If judgment is not paid in full within one hundred eighty (180) days of entry, then interest shall accrue at the annual rate of ten percent (10%) from date of entry.
 - 8. The Court costs of this action shall be borne by Pangaea.
