Fifth District Use of Community Improvement Designation Funds

BACKGROUND: The City of Palm Springs donation will be used to support the Veterans Day Parade. The donation for the Boys Scouts of America Three Peaks District will provide support for overall scouting programs. The March Field Museum Foundation funds will be used to support the MASH Bash fundraiser honoring the March Air Reserve Base medical personnel and will support the museum's educational programs and community activities. 46th DAA Southern California Fair donation will assist with services they provide the community which will serve the youth and low-income. The Riverside County Animal Services funding will be used will assist with reducing the cost of adoptions and services needed to support the adoption process.
