

BACKGROUND:

1. The Flying Doctors & CV Medical Volunteers event is one of the largest mobilization efforts of healthcare professionals, agencies, community-based organizations, and volunteers in the Coachella Valley. Last year efforts resulted in helping to improve the health and well-being of the underserved and uninsured population living in the Coachella Valley. Over 2,200 people received medical, dental and vision services, education activities, and resources.

2. The Desert Hot Springs Family Resource Center will be holding its 3rd annual holiday event Build-A-Bike Project. This event is a way to help families during the holiday season as well as encourage exercise and healthy activities for their children. Last year forty four underserved children from twenty two low income families in Desert Hot Springs, Thousand Palms and Palm Springs received bikes and helmets. This project is also supported by the local communities with donations from residents and local organizations.

3. Palm Desert Sister Cities Foundation are acknowledging and honoring Councilmember Jean Benson who has devoted herself to the City of Palm Desert and the Coachella Valley as a public servant for a period spanning five decades. Through her dedication and leadership Jean Benson has had a positive influence in a variety of public policies in Palm Desert and the surrounding Coachella Valley. Proceeds from the event will benefit the Palm Desert Sister Cities Foundation and Soroptimists International Palm Desert.
