On motion of Supervisor Tavaglione, seconded by Supervisor Stone, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, October 28, 2014, be adjourned in memory of Michael David Davis Jr., a 42-year-old Placer County Sheriff's Department Investigator who was shot and killed on October 24, 2014, while taking part in a massive manhunt for the murderer of a Sacramento County Sheriff's Deputy.

A 15-year veteran of the Placer County Sheriff's Department, Michael first joined the department as a reserve deputy sheriff in 1996. He then became a police officer with the City of Auburn and came back to the Sheriff's Department in 1999. For the last 10 years, he served as a homicide investigator. His tragic death occurred exactly 26 years to the day that his father, Investigator Michael David Davis Sr., was killed in the line of duty on October 24, 1988, while serving with the Riverside County Sheriff's Department.
