**RECOMMENDED MOTION:** That the Board of Supervisors:

Direct the Treasurer-Tax Collector's Office to prepare and process the ordinance amendment.

Government Code Section 27000.1 provides that the Board may by ordinance delegate investment authority to the County Treasurer. Pursuant to Government Code Section 53607 an annual delegation of such authority is required. **BACKGROUND:**

**Summary (continued)**

Pursuant to the proposed ordinance amendment, the County Treasurer would continue to fulfill his fiduciary responsibilities to invest and reinvest funds of the County and other depositors and continue selling or exchanging securities and depositing and safe keeping funds.

Subject to the Board's approval, the Treasurer-Tax Collector's Office will prepare and process the appropriate ordinance amendment.

**FISCAL:** The costs of preparing and processing the ordinance amendment will be approximately \$500. All of these costs are reflected in the Treasurer-Tax Collector's FY 2014-2015 budget. No budget adjustment is requested.
