

BACKGROUND: CONTINUED:

1. **Michelle's Place, Breast Cancer Resource Center-\$10,000** Michelle's Place is a full service breast cancer resource center providing free services to women and their families in Riverside County. The target population includes women dealing with breast cancer. These individuals include recently diagnosed, currently going through treatment and survivors. Also, one of the largest programs is to provide uninsured, low income women who have a symptom of breast cancer with diagnostic breast health services.
2. **Hospice of the Valleys- \$3,000-** provides much needed medications, equipment and bereavement service for patients and families with no insurance coverage.
3. **Greater Idyllwild Tree Lighting Committee- \$1,000** for the 53rd annual Idyllwild Christmas Tree Lighting Ceremony, "An Olde Fashioned Christmas' event. The funding will be used electrical spider box to support 1000 lights, sound equipment for the event. This event provides an opportunity to showcase the community of Idyllwild attracting people to patronize local businesses.
4. **City of Temecula and Community Mission of Hope- \$5,000** to provide inclement weather shelter program. The program offers warm shelter during winter months with services that include: meals, showers/hygiene/toiletries, clothing, transportation, medication, bedding, identification and coaching as needed.
5. **The Unforgettables Foundation -\$2,500** assists low-income families with the cost of a dignified burial/cremation of a child.
