

BACKGROUND: CONTINUED:

1. **Community Outreach Ministry- \$500** to help children of incarcerated parents, at-risk and troubled teens to break the cycle of oppression, drugs, poverty and illiteracy. Community Outreach Ministry provides intervention and direction through year round outreach, camping and mentoring programs for children to build healthy futures. Specifically, the funds will be used for food and clothing for 200 children.
2. **Law Enforcement Appreciation Committee-\$500** for sponsorship of 37th Annual Law Enforcement Appreciation Ceremony to recognize officers for valor, investigative excellence in community service, lifetime achievement and distinguished K9 team.
3. **Mount San Jacinto College Foundation-\$2,500** the primary mission is to promote and support student success and enhance the quality of higher education throughout the district. The foundation will use the funds to provide scholarships to financially assist students achieve their educational goals.
4. **Riverside County Foundation on Aging- \$2,500-** to support the senior nutrition programs at the San Jacinto Community Center.
5. **Valley Restart Shelter- \$10,000-** Valley Restart Shelter safety and security project, the funding will utilized to paint the exterior of the building, purchase much needed chairs, install security cameras, enhance outside lighting and repair parking lot.
