BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Riverside County Professional Firefighters Benevolent Fund - \$2,000** funding will assist with "Shop with a Firefighter" that provides clothing, school supplies and personal necessities to children selected with the assistance of the Riverside County Child Protective Services department.
2. **Catholic Charities of San Bernardino and Riverside Counties - \$2,500** funding will be used to provide social services such as food, utility, and housing assistance to families residing in the First District.
3. **Riverside Dickens Festival - \$1,000** funds will be used to support one of the signature events in Riverside-- the annual cultural festival celebrating the life and works of Charles Dickens and the Victorian Era. This event is free and open to the public.
4. **Riverside Road Runners - \$1,000** funding will be used to assist with race entries and running shoes to under-privileged athletes.
5. **Riverside County Foundation on Aging- \$5,000** funding will be used to assist the foundation with their Holiday Gift Program. Through this program, seniors are selected from each Senior Center in the 1st District to receive a Stater Bros Gift Card to be used for the holidays.
