
**SUBJECT:** Update Regional Access Project Term Limits

**BACKGROUND:** The Regional Access Project Foundation (RAP) incorporated in 1992 as a 501 C (3) public benefit corporation in order to address unmet needs in health, mental health and juvenile intervention for residents of eastern Riverside County through grants and technical assistance to tax exempt agencies and organizational service providers. RAP is funded through grants, private donations, fund raising and a unique agreement with the County of Riverside.


