Raised in Charlotte, North Carolina, Barnett was the son of a slave who "led an extraordinary life marked by achievement and commitment." A physicist, businessman, teacher, author, and leader in the local civil rights movement, he brought "intelligence, passion, and perspective to many different causes and groups."

While working as a physicist, Barnett's family was one of 52 families transferred to the Naval Weapons Center in Corona by the U.S. Bureau of Standards, Missile Division, to form a west coast division. After arriving in Riverside in 1951, he overcame racial discrimination and became an inspirational force in the community.

Barnett founded Habitat for Humanity in Riverside, established a college scholarship for Riverside students, and established a Leadership Academy named for his wife Eleanor, who preceded him in death. He "made a difference in education and was instrumental in establishing an advisory committee on African American students." The Grier Pavilion, named after Barnett and his wife, was opened on the seventh floor patio of the Riverside City Hall in 2008.

Barnett was a loving and devoted family man and friend who "touched many lives in Riverside during his 99 years." His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.
