BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the March 16, 2009 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 05, 2009. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 4, 2009, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest. BACKGROUND: Summary (continued)

The Treasurer-Tax Collector has received three claims for excess proceeds:

- Claim from Global Discoveries, Ltd, assignee for Robert Holmes and Susan Holmes based on an Assignment of Right to Collect Excess Proceeds dated April 4, 2009 and a Corporation Grant Deed recorded September 28, 1998 as Instrument No. 414558.
- Claim from Riverside County Treasurer-Tax Collector based on a Certificate of Lien recorded November 19, 2007 as Instrument No. 0701582.
- 3. Claim from Riverside County Treasurer-Tax Collector based on a Certificate of Lien recorded November 6, 2008 as Instrument No. 0590733.

Pursuant to Section 4675 (a) & (b) & (e) of the California Revenue and Taxation Code, it is the recommendation of this office that Global Discoveries, Ltd, assignee for Robert Holmes and Susan Holmes be awarded excess proceeds in the amount of \$4,963.19. The claims from Riverside County Treasurer-Tax Collector be denied since the liens filed are not associated with the last assessees. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

Impact on Citizens and Businesses

Excess proceeds are being released to the last assessees of the property.




