

**BACKGROUND/APPOINTEE INFORMATION:** Major General, USMC Reserve, (Retired) William G. Groeniger served in the United States Marine Corp on Active Duty as a Naval Aviator. After his Honorable Discharge from Active Duty with the United States Marine Corp he joined the United States Marine Corp Reserve. The Major General served in the USMC and USMCR for a combined total of 31 years. During his service he received numerous awards, decorations, service badges and devices for his patriotic service. He has also enjoyed a very successful career in the private sector rising to CEO of a San Diego County based firm and currently serves as Chairman Emeritus and a director of Marden Susco, Inc. Major General Groeniger has maintained his strong ties to the Marine Corp and presently serves on the Board of Directors of the Marine Corps University Foundation, supporting Active Duty marines since 1980. He is also the former Chairman of the Board of the Marine Corps Aviation Association and a former deputy commander of the Marine Corps Aviation Association & past Chairman of the Marine Toys for Tots Foundation.
