SUBJECT: Approval for equipment purchase of the VNX 5400 Server / Storage System with Sirius Computer Solutions without obtaining competitive bids. [All District; \$123,246; Enterprise Funds]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Authorize and approve the Purchasing Agent to execute the purchase order to Sirius Computer Solutions for the VNX 5400 Computer Server / Storage System for \$123,246, with three (3) years of hardware and software maintenance support; and,
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459 to sign maintenance support agreement and subsequent amendments that do not change the substantive terms of the agreement.

BACKGROUND:

Summary (continued)

This equipment is highly anticipated and will be used for the following critical RCRMC operations:

- To support the Virtual Clinical Desktops within the dynamic hospital environment
- Provide sufficient disk space for User Shares
- Local file storage for the RCIC Data Center Virtualization Project

Impact on Citizens and Businesses

There is no direct impact.

Contract History and Price Reasonableness

The computer equipment is already on site, is functional, and is an essential component of the Siemens system. The purchase provides continuity of the server and support to RCRMC patients and staff. To change equipment and/or vendor would cause unnecessary disruption and possible loss of resources and will cost \$140,000 to replace.

Leasing this equipment for two (2) years would have cost the county \$245,496. A purchase price of the existing equipment in the amount of \$123,246 was negotiated through the Riverside County Purchasing Department, saving the County \$122,250.

The below information is provided in support of my Department requesting approval for a sole source. Outside of a duly declared emergency, the time to develop a statement of work or specifications is not in itself justification for sole source.

1. **Supply/Service being requested:** Sirius/EMC VNX 5400 Server Storage System
2. **Supplier being requested:** Sirius Computer Solutions (RIVCO Vendor ID # 0000046246)
3. **Alternative suppliers that can or might be able to provide supply/service:** Not applicable.
4. **Extent of market search conducted:** Not applicable.
5. **Unique features of the supply/service being requested from this supplier, which no alternative supplier can provide:** This VNX Hardware is currently on site at the Riverside County Regional Medical Center/CPC Building. The hardware was provided by Sirius to the County of Riverside over a year ago to demo the equipment, while meeting immediate needs. However, at that time there were no funds available to complete this purchase. Because of the vendor-client relationship, Sirius took the unusual step of providing the use of this hardware at no cost. The server is currently networked with the Siemens computer system.

RCRMC has a mandated requirement to contain and secure its data. Currently unused network storage space is nearly unavailable putting user and patient data at risk. This purchase provides necessary, additional network storage to support the growing environment and protects confidential patient data used throughout RCRMC.

This equipment is highly anticipated and will be used for the following critical RCRMC operations:

- To support the Virtual Clinical Desktops within the dynamic hospital environment
- Provide sufficient disk space for User Shares
- Local file storage for the RCIC Data Center Virtualization Project

6. **Reasons why my department requires these unique features and what benefit will accrue to the county:** Since this equipment is already on site and functional; the purchase provides continuity of server and support to RCRMC patients and staff. To change equipment and/or vendor would cause unnecessary disruption and possible loss of resources.

This service impacts the patients in Riverside County receiving care from RCRMC. Because RCRMC provides life-saving care to this region's population, the need for continuity and efficacy of provided services is well understood. This purchase is a necessary upgrade to continue to meet demands and expectations.

- 7. **Price Reasonableness including purchase price and any ongoing maintenance or ancillary costs from the supplier:** Given that the lease price was costly, a purchase was negotiated along with three (3) years of free hardware and software maintenance support and upgrades for a total amount of \$123,246.36

- 8. **Does moving forward on this product or service further obligate the county to future similar contractual arrangements or any ongoing costs affiliated with this sole source? (Maintenance, support, or upgrades, if so, please explain).** No, pricing is all inclusive.
