


BACKGROUND/APPOINTEE INFORMATION: David M. Rodrigues served 42 years with the National Guard of the United States and the States of California and Hawaii. He reached the rank of Brigadier General while serving as the Commander of the Hawaii Air National Guard and Assistant Adjutant General of the Hawaii National Guard & Department of Defense. He began his career as an enlisted member rising thru the ranks to Master Sergeant and later earned a commission. He served as a Combat Communications Officer and Radar Officer during his distinguished career in the California and Hawaii Air National Guard. As a member of the Guard he deployed for training to the Republic of Korea and served as the Commander of the 234th Combat Communication Squadron. He played a key role in the numerous recovery operations following hurricanes that struck the Hawaiian mainland, directing recovery operations and conducting rescue operations with the Hawaiian National Guard & Department of Defense. He retired in 1995 after 42 years of service. He has devoted his entire life to service of his nation and States of Hawaii and California. Brig. Gen. Rodrigues received numerous awards & decorations for his patriotic military service from the United States Air Force and the State of Hawaii Department of Defense. He maintains close ties with his fellow retirees with the Hawaii National Guard and is active in his community. He resides in the 5th District and will make an outstanding representative of the district and brings great judgment and leadership to this post.
