22 The above-captioned matter came on regularly for hearing on December 2, 2014, before the
23 Board of Supervisors of the County of Riverside, State of California in the Board Room, First Floor
24 Annex, County Administrative Center, 4080 Lemon Street, Riverside, California regarding the real
25 property described as 26160 Homeland Avenue, Homeland, Riverside County, and further described
26 as Assessor's Parcel Number 459-105-001 referred to hereinafter as "THE PROPERTY."

27 Sophia Choi, Deputy County Counsel, appeared along with Michelle Cervantes, Senior Code
28 Enforcement Officer, on behalf of the Director of the Code Enforcement Department.

Owner did not appear.

The Board of Supervisors received the Declaration of Code Enforcement Officer together
with the attached exhibits, evidencing the accumulation of rubbish on THE PROPERTY as a public
nuisance and violation of Riverside County Ordinance No. 541.

1 **SUMMARY OF EVIDENCE**

2 1. Documents of record in the Riverside County Recorder’s Office identify the owner of
3 THE PROPERTY as Viola B. Hutchinson (“OWNER”).

4 2. Documents of title indicate that other parties potentially hold a legal interest in THE
5 PROPERTY, to wit: Viola B. Hutchinson, Trustee of the Viola B. Hutchinson Revocable Living
6 Trust dated March 7, 2002 and Joan Brashear (hereinafter referred to as “INTERESTED
7 PARTIES”).

8 3. THE PROPERTY was inspected by Code Enforcement Officers on May 7, 2014,
9 July 2, 2014, July 24, 2014, September 10, 2014 and November 25, 2014.

10 4. During each inspection, an accumulation of rubbish was observed on THE
11 PROPERTY. The rubbish consisted of, but was not limited to: household trash, burnt wood, 4 tires,
12 cement pillars, clothing and wooden stairs in excess of 1,800 square feet.

13 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance
14 No. 541 by the Code Enforcement Officer.

15 6. A Notice of Pendency of Administrative Proceedings was recorded in the Office of
16 the County Recorder, County of Riverside, State of California on July 16, 2014, as instrument
17 number 2014-0264789.

18 7. On May 7, 2014, a Notice of Violation was posted on THE PROPERTY. On May 7,
19 2014, a Notice of Violation was mailed to OWNER by certified mail, return receipt requested. On
20 July 30, 2014, a Notice of Violation was mailed to OWNER and INTERESTED PARTIES by
21 certified mail, return receipt requested.

22 8. A “Notice to Correct County Ordinance Violations and Abate Public Nuisance”
23 providing notice of the public hearing before the Board of Supervisors on December 2, 2014, was
24 mailed to OWNER and INTERESTED PARTIES and was posted on THE PROPERTY.

25 **FINDINGS AND CONCLUSIONS**

26 WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in
27 regular session assembled on December 2, 2014, finds and concludes that:

28 1. WHEREAS, the accumulation of rubbish on the real property located at 26160

1 Homeland Avenue, Homeland, Riverside County, California, also identified as Assessor's Parcel
2 Number 459-105-001 violates Riverside County Ordinance No. 541 and constitutes a public
3 nuisance.

4 2. WHEREAS, the OWNER, or any person having possession or control of the premises
5 shall abate the condition by removing and disposing all accumulated rubbish from the subject real
6 property in strict accordance with all Riverside County Ordinances, including but not limited to
7 Riverside County Ordinance No. 541 within ninety (90) days.

8 3. WHEREAS, the OWNER and INTERESTED PARTIES ARE FURTHER NOTICED
9 that the time within which judicial review of the administrative determinations made herein must be
10 sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and
11 Order to Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

12 **ORDER TO ABATE NUISANCE**

13 IT IS THEREFORE ORDERED that the accumulation of rubbish on THE PROPERTY be
14 abated by OWNER or anyone having possession or control of THE PROPERTY, by removing and
15 disposing of all rubbish from the subject real property in strict accordance with all Riverside County
16 Ordinances, including but not limited to Riverside County Ordinance No. 541 within ninety (90)
17 days of the date of this Order to Abate Nuisance.


18 IT IS FURTHER ORDERED that if the rubbish is not removed and disposed of in strict
19 accordance with all Riverside County Ordinances, including but not limited to Riverside County
20 Ordinance No. 541, within ninety (90) days of the date of this Order to Abate Nuisance, the rubbish
21 may be abated and disposed of by representatives of the Riverside County Code Enforcement, a
22 contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order
23 authorizing entry onto THE PROPERTY when necessary under applicable law.

24 IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity
25 for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special
26 assessment against THE PROPERTY pursuant to Government Code section 25845 and Riverside
27 County Ordinance Nos. 541 and 725. Under Riverside County Ordinance No. 725, "abatement
28 costs" means "any costs or expenses reasonably related to the abatement of conditions which violate


1 County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation,
2 collection and administrative costs, attorneys fees, and the costs associated with the removal or
3 correction of the violation." Reasonable abatement costs accrued by the Code Enforcement
4 Department will be recoverable from the property owner(s) even if THE PROPERTY is brought into
5 compliance within ninety (90) days of the date of this Order to Abate Nuisance.

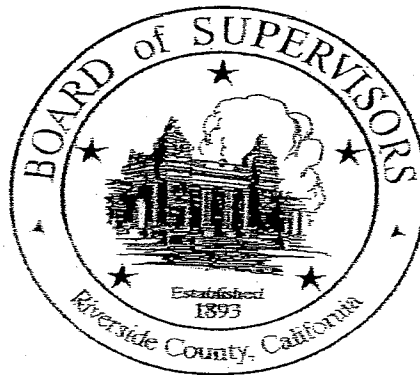
